SUBJECT: REACH INFORMATION - GEWISS ARTICLES

Dear customer,

following your kind request, we would like to inform you that according to the **EC Regulation No 1907/2006 (REACH Regulation)** of 18/12/2006 and subsequent amendments, GEWISS S.p.A. is a **DOWNSTREAM USER / SUPPLIER OF THE ARTICLES** and for this reason, it does not have to register its products.

In particular GEWISS, in order to ensure the compliance with the Reach Regulation, asks its raw materials and components suppliers to:

- be acquainted with REACH requirements and fulfill them;
- constantly check the updating of SVHC substances list (candidate list of very high concern substances);
- provide GEWISS with full and accurate information related to the possible presence of SVHC substances within the substances/preparations/articles supplied.

At the current state of available knowledge:

- based on the communications received from suppliers until now and considering that, within the GEWISS manufacturing processes, SVHC substances included in the candidate list are not present or intentionally added, we inform you that these substances are considered absent from GEWISS articles listed below:

- based on the communications received from suppliers until now, we inform that into some components of Gewiss article listed below is present a SVHC substance in a quantity exceeding the 0.1% (weight/weight).

Therefore, as required by ECHA, we submitted the notification in the European SCIP d database.
